DECEMBER 2023: MACCI MEMBER NOCKE AT THE ANNUAL CRA BRUSSELS CONFERENCE

MaCCI Senior Member Volker Nocke participated at the annual CRA Brussels Conference on 6 December 2023. He spoke at a panel on „From more economic approach to which economic approach.“ The other panelists included Paula Blizzard, California’s Senior Assistant Attorney General for Antitrust, and Linsey McCallum, the European Commission’s Deputy Director-General of Antitrust & Regulation of Digital Platforms.

DECEMBER 2023: MACCI MEMBER PEITZ AT JAPAN FAIR TRADE COMMISSION AND COMPETITION COMMISSION OF INDIA

The programme contained diverse topics, covering methodological contributions in demand estimation and industry-focused discussions on key sectors such as automotive and retail.

SEPTEMBER 2023: MACCI MEMBER JOINS THE BOARD OF THE RAND JOURNAL OF ECONOMICS AS ASSOCIATE EDITOR

MaCCI Member Nicolas Schutz has become associate editor of the RAND Journal of Economics.

AUGUST 2023: THIRTEEN MACCI RESEARCHERS PRESENTED AT THE EARIE CONFERENCE IN ROME

This year's annual meeting of EARIE in Rome featured a large number of presentations from MaCCI researchers:

JULY 2023: INTERNATIONAL SCHOLARS DISCUSS DIGITAL ECONOMY AT ZEW

On 6 and 7 July 2023, the ZEW Research Unit “Digital Economy” hosted the 21st Conference on the “Economics of Information and Communication Technologies”. Held at ZEW Mannheim, the event attracted international scholars who presented and discussed their latest empirical and theoretical research findings in two parallel sessions. The annual conference was organised by Professor Irene Bertschek, Francesco Clavoreà Braulin, Ph.D., and Dr. Dominik Rehse, and has been regarded as one of the most important scientific conferences in the field of digital economy for many years. This is evident from the submission of over 100 scientific papers and the registration of around 85 participants for this year's edition.

Over the course of 14 sessions, a diverse range of topics were explored, including digital technologies, innovations, platforms, privacy, data economy, and social media. Between sessions, scholars had valuable opportunities to exchange ideas about their current research and extend their networks.

JULY 2023: MACCI RESEARCHERS AT CRESSE 2023

Five MaCCI researchers, namely, Jacopo Gambato, Nadine Hahn, Martin Peitz, Helena Perrone, and Anton Sobolev, presented recent research findings at the 17th Competition and Regulation Summer School and Conference (CRESSE) in Rhodes. In addition, Martin Peitz taught in the summer school of CRESSE to competition practitioners.

JUNE 2023: MACCI MEMBER PEITZ AT THE KOREAN FAIR TRADE COMMISSION

MaCCI Director Martin Peitz gave a lecture on German competition policy developments regarding Big Tech at the Korean Fair Trade Commission. He also had various exchanges on developments in competition practice in South Korea.

JUNE 2023: MACCI MEMBERS FRANCK AND PEITZ EXPERTS AS GERMAN PARLIAMENT HEARING ON THE ELEVENTH AMENDMENT OF THE GERMAN COMPETITION ACT

MaCCI Directors Jens-Uwe Frank and Martin Peitz were two of the eight experts who spoke at the expert hearing of the German parliament on the eleventh amendment of the German Competition Act.

Most of the discussion was about the market investigation tool that would give additional power to the German Cartel Office.

MAY 2023: MACCI WELCOMES JUNIOR RESEARCHERS IN COMPETITION LAW AND ECONOMICS FOR CLEEN CONFERENCE 2023

On 25 and 26 May 2023, MaCCI hosted the 2023 CLEEN Conference. Our members Bernhard Ganglmair, Helena Perrone, and Francisco Poggi served as local organizers.

CLEEN is the Competition Law and Economics European Network. It has provided an interdisciplinary platform for researchers in the field of law and economics since its first research workshop in Bonn in 2007. CLEEN organizes an annual conference for Ph.D. students and postdoctoral researchers from economics and law to present their work on competition law, economics, and policy and receive feedback from senior faculty members.

This year's conference program comprised 24 presentations by junior researchers and four short lectures by senior faculty members from CLEEN network institutions. We were also thrilled to have had Tomaso Duso (TU Berlin, DIW Berlin, and German Monopolies Commission) and Michal Gal (University of Haifa, Faculty of Law) as keynote speakers.

MAY 2023: MACCI IO DAY

Last year's MaCCI IO Day was held on 5 May 2023. More than 30 members gathered for a day of presentations and discussions of papers on productivity, carbon pricing and emission fees, block chain, search, platforms, and innovation.

The MaCCI IO Day is an annual workshop for members of the departments of law and economics as well as ZEW to present current theoretical and empirical research in the field of industrial organization - in its full variety of shades and colours.

APRIL 2023: NEW RESEARCH ON SELF PREFERENCING BY PLATFORMS PRESENTED AT A MACCI/EPOS EVENT

On 25 April, Chiara Farronato (Harvard Business School) presented new empirical work documenting that Amazon engages in self-preferencing on its marketplace by systematically favouring its own brands in search results.

APRIL 2023: NEW RESEARCH ON PRICE COMPETITION AND CONSUMERS' PERCEPTION OF PRODUCT DIFFERENTIATION AT A MACCI/EPOS SEMINAR

On April 18, Gary Biglaiser (University of Northern Carolina) presented new theoretical work on the interplay between price competition and consumers' perception of product differentiation, with applications to the optimal choice of business model by a dominant platform.

MARCH 2023: WORKSHOP ON COMPETITION AND CORPORATE LAW

On 27 and 28 March 2023, MaCCI, in cooperation with Lund University and the University of Strasbourg, hosted a workshop at ZEW on the relationship between competition law and corporate law.

Five sessions examined various aspects of the interplay, such as common ownership, compliance,

and corporate governance. After introductory short presentations, participants engaged in fruitful discussions. Speakers offered not only the EU perspective, but also insights from the US, Israel, and Japan. In addition to 15 in-person participants, many academics also took part via Zoom. The workshop served to prepare a Research Handbook on Competition and Corporate Law, edited by Florence Thépot and Anna Tzanaki, to be published later this year.

MARCH 2023: TWELFTH MACCI ANNUAL CONFERENCE WITH A FOCUS ON ANTITRUST AND DIGITAL ECONOMICS

MaCCI hosted its twelfth annual conference on 23–24 March 2023 at ZEW Mannheim. This year's conference programme consisted of approximately 80 presentations in parallel sessions, two keynote speeches, and a panel discussion. With over 120 participants, this was the largest in-person MaCCI Annual Conference to date.

The first conference day focused on various aspects of the digital economy, merger analysis, and market power from both an economics and a law perspective. A highlight of the first conference day was the keynote speech by Professor Niamh Dunne from the London School of Economics (LSE).

FEBRUARY 2023: MACCI MEMBER JOINS THE BOARD OF THE JOURNAL OF INDUSTRIAL ECONOMICS AS ASSOCIATE EDITOR

MaCCI member Nicolas Schutz has become associate editor of the Journal of Industrial Economics.

FEBRUARY 2023: MACCI MEMBER LEI LI APPOINTED AS CESIFO RESEARCH FELLOW

Our MaCCI member Lei Li has been appointed CESifo Research Fellow in the Global Economy Area.

In her research, Prof. Li evaluates the economic impact of trade policies (focusing on the US-China trade dispute), studies the labour market consequences of globalization (with a special focus on skill-biased technological change, industry cluster, wage inequality, human capital accumulation, and migration), and examines the impact of globalization on the environment and health. FEBRUARY 2023: MACCI BOARD MEMBER BERNHARD GANGLMAIR ON EXPERT PANEL AT FRC

MaCCI board member Bernhard Ganglmair participated in a panel discussion at the Financial Reporting Council, UK's regulator of auditors, accountants, and actuaries. The panel was part of the Workshop on Competition and Innovation in the UK Audit Market, organised by the Centre of Competition Policy at the University of East Anglia and the Financial Reporting Council. Professor Ganglmair was invited as an outside academic expert on the topic.

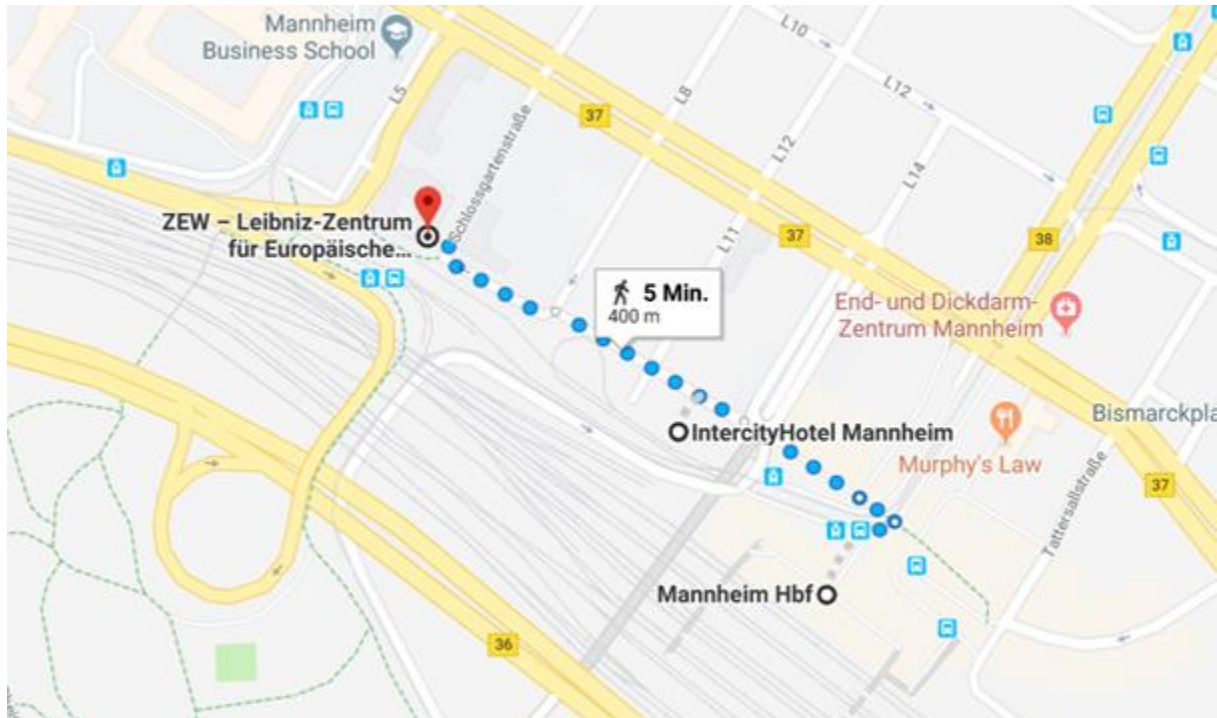
